

BOARD OF DIRECTORS MEETING MINUTES January 14, 2016 6:00 p.m. Fort Myers, Florida

- II. Reports
 - a. November 2015 Board of Directors Meeting Minutes Jeremy McBryan

 A motion to approve the draft November 2015 Board of Directors (BOD) Meeting Minutes as submitted to the BOD was approved.
 - b. Treasurer Mark Diblin

In 2015, approximately \$4,000 was distributed to students to assist with conference/meeting participation and travel and approximately \$12,000 in scholarships and grants was awarded. A financial summary for January 1 – December 31, 2015 was provided (see attached report): Total income: \$57,400; Net expenses: \$51,000. The November 2015 technical meeting in Daytona Beach (aka the 2015 ShORE Symposium) raised approximately \$2,000, which was split between AWRA Florida, Daytona State College and the Marine Discovery Center. Mark Diblin was also directed to send \$1,000 (\$500 each for 2014 and 2015) to the AWRA's Richard A. Herbert Memorial Educational Fund as was budgeted. A motion to accept the Treasurer's report as submitted was approved.

c. Education – Kristin Bennett

The Education Committee, in conjunction with AWRA, sent a letter the President of Oxbridge Academy of the Palm Beaches recognizing the efforts and success of the Oxbridge students at the November 2015 National water resources conference and at the February 2016 Southwest Florida Water Resources Conference. 2016 Scholarship/Grant applications are due May 15, 2016. Gordon Brown, former University of Florida Student Chapter President, volunteered to assist with the Education Committee.

d. Newsletter – Gregg Jones

The target February 2016 newsletter preparation/review/distribution schedule is as follows:

Jeremy reported that AWRA Florida has 185 members so far in 2016 and the breakdown is as follows: Professional = 83; Student = 92; Fellow = 3; Life = 7. The call for special sessions for the November 2016 Annual Conference will go out soon. Also, the AWRA BOD is looking for ways to strengthen ties between state sections and AWRA.

Tyson with a gift card for his time and effort in preparing the newsletters. The BOD approved a motion to give \$250 to Michael Tyson.
